The school will have a variety of different classroom and multipurpose spaces including, art rooms, science labs, music rooms, ESE Rooms, locker rooms, and an indoor gymnasium. New kitchen and dining facilities along with an administration wing are also planned. The new building totals over 180,000 SF and will add over 1,900 student stations.
	Site construction will include extensive storm drainage, the construction of an athletic field, running track, exterior basketball courts. There is also numerous exterior aluminum canopies and two planned pre-engineered metal building structures.
